Industry Support for Upskilling of Existing Employees and Nomination of Experts and Jury for Skill Competitions

Capital Goods Skill Council (CGSC) is an industry led organisations set up by Capital Goods Industry as with the support of the Government as a Society under the Societies Act. The support required from Industry is for nominating the Experts and Jury for smooth and fair conduct of these skill competitions. - b) Names of the nominated Experts and Jury for the States participating in the 7 skills as listed in Annexure C. Kindly share the names and other details of the nominated Experts and Jury as per format attached in Annexure E by 27 Feb 2018.
