Peru is a democratic republic. The Peruvian economy, which is the seventh largest in Latin America in terms of nominal GDP and sixth in terms of GDP (PPP), has experienced a structural change in the past three decades & offering wide opportunities for engineering goods & equipments.

The Show will exhibit around 100 Indian companies from Metalworking, Automotive, Casting & Forging, Wires, Pumps, Steel, & various engineering items. Peru imports a vast array of engineering products from the world. Its total engineering import stands at 20144.3 million USD in 2013, out of which 261.27 million USD worth of imports are sourced from India, indicating India's share of 1.30% in Peru's global import of engineering goods.

On the other hand, India exported only 0.4% of its engineering exports to Peru in 2013. So far, the Indian export basket of engineering goods to Peru have been dominated by automobiles and components, electrical machinery and equipment, products of iron and steel and machineries of various kinds. The potential items for exporting from India have been listed out in the product profile of the exhibition below.
